SWORN STATEMENT AND AFFIDAVIT

TO: ALL UNITED STATES DISTRICT JUDGES AND ALL JUDGES OF ANY  
STATE COURT OF THE UNITED STATES OF AMERICA.

"My name is Professor dr hab. Zdzislaw Kleinrok. I am the President of the Medical Academy in Lublin, Poland. The Lublin Academy is a medical school in Poland, which is operated under the Ministry of Health of the Republic of Poland. The Ministry of Health is an agency and department of the Government of the Republic of Poland. As President of the Medical Academy, I am a government official appointed by the Ministry of Health as President of the Medical Academy. I have occupied my official position for the Government of Poland as President of the Medical Academy since Sptember, 1984..

As the President of the Medical Academy of Lublin, Poland, I am the person in charge of all transcripts and records of former medical students who attended the Medical Academy. I have the authority to release records of former students who attended the Medical Academy when a proper request is made. I am also in charge, as a government official of the Medical Academy, to make certain statements as to what is contained in the records of the Medical Academy.

I have reviewed the records and transcripts of the Medical Academy pertaining to Stanislaw R. Burzynski, who is a former medical student of the Academy. Dr Stanislaw R. Burzynski was accepted as a student to the Medical Academy in Lublin,

Poland in 1961. He completed a full course of studies of medicine and graduated from the Medical Academy on February 18, 1967. The records of the Medical Academy reflect that he was the best student in his class. Dr Stanislaw Burzynski graduated with Distinction and received a diploma of Medical Academy Doctor on June 30, 1967 from our Medical Academy. Attached hereto is a xerox copy of his diploma.

Our records also reflect that Dr Stanislaw R. Burzynski continued his education at the Medical Academy in Lublin, Poland after his graduation as a medical student. His additional education was related to the study of biochemistry. On October 16, 1968, Dr Stanislaw R. Burzynski also received a Ph. degree from the Medical Academy in Lublin, Poland for his studies in bochemistry.


As President of the Medical Academy in Lublin, Poland I hereby affirm and swear that our records reflect that Dr Stanislaw R. Burzynski was one of the very best students who ever attended and graduated from the Medical Academy. The Medical Academy has graduated approximately 9486 medical doctors since it was first opened in 1944. I have personal knowledge that many of these same graduated doctors have immigrated to the United States and are today practicing medicine in the United States, either as surgeons or internal medicine doctors or other types of doctors.
